



Who We Are

Chilhams Future Delivery Board (CFDB) is a registered company limited by guarantee with charitable objects and registered in England No.6212253. It was incorporated at the instigation of Chilham Parish Council (CPC) in 2007 as this was seen as the most prudent vehicle for project delivery. CFDB's activities are bound by the Memorandum of Association and Articles of Association which can be accessed direct from our website – www.chihamsfuture.co.uk. The content of these documents is tightly prescribed by the Charities Acts, Companies legislation and guidelines such as those issued by the Charity Commissioners.

CFDB were tasked by CPC to take forward improvements to the Square following the result of the community engagement exercise and the selection of a preferred proposal for Chilham Square.

The main objectives of CFDB are :

- to deliver Chilham Village Square's long-term regeneration and environmental improvement project
- to improve the chances of success with funding applications

The key aim of the project is:

- to deliver a quality, environmental improvement and refurbishment scheme ('the scheme') for Chilham Parish

As a result it is hoped the community will benefit from the ability :

- to promote the sustainable physical, social and economic revitalisation of the whole parish by encouraging tourism: in particular, by unlocking the key potential of the square as a unique and beautiful medieval open space
- to improve the competitiveness of Chilham village in difficult economic circumstances; promote local businesses, employment and associated activities

Applying For Membership

Membership of CFDB is available to any Chilham resident, parishioner, business, or organisation that live or work in Chilham and support the aims of the Charity.

CFDB has the following categories of membership:

Ordinary membership

Any person who is a resident or who works in the Parish of Chilham ('the Parish') may be an Ordinary Member provided he/she agrees to support the aims of the Charity. Ordinary Members are entitled to vote at Annual General Meetings.

Associate membership

Any business, organisation or society which has its principal place of business and activity within the Parish may be an Associate Member provided that, through its authorised representative, agrees to support the aims of the Charity. Associate Members are not entitled to vote at Annual General Meetings.

Joining Fees

There are no fees payable by either Ordinary Members or Associate Members.

Members Responsibilities and Liabilities

Every Ordinary Member promises, if the Charity is dissolved while he or she is a Member or within twelve months after he or she ceases to be a Member, to contribute such sum (not exceeding £10.00) as may be demanded of him, or her, towards the payment of the debts and liabilities of the Charity incurred before he or she ceases to be a Member, and of the costs charges and expenses of winding up, and the adjustment of the rights of the contributories among themselves.

Members, whether Ordinary or Associate, are expected to support CFDB in achieving its objectives in any way they can.
